NAPA COURT ROLLS OUT ABILITY-TO-PAY ONLINE TOOL FOR INFRACTIONS

Napa, CA – As part of its continued focus on access to justice, the Napa County Superior Court recently rolled out an online option for individuals struggling to pay fines related to infractions.

The tool—called MyCitations—is an online application that offers people the option to request a reduction for their infraction citation, particularly in cases where there is financial need. This new tool launched earlier this month and is available on the court’s website.

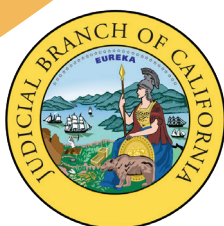
MyCitations was developed, and is maintained by, the Judicial Council of California. The application allows low-income individuals with infraction violations to request a reduction in their fines and fees without going to the courthouse. Users can also request a payment plan, more time to pay, or community service.

The application will also allow individuals to enter a plea of guilty or nolo contendere and resolve a qualifying citation electronically if a mandatory appearance is not required. This new option saves both time and resources, and allows the public to make requests without the need to appear in court. Prior to the implementation of this ability-to-pay tool, only those that had previously made payment arrangements with the court could pay online. 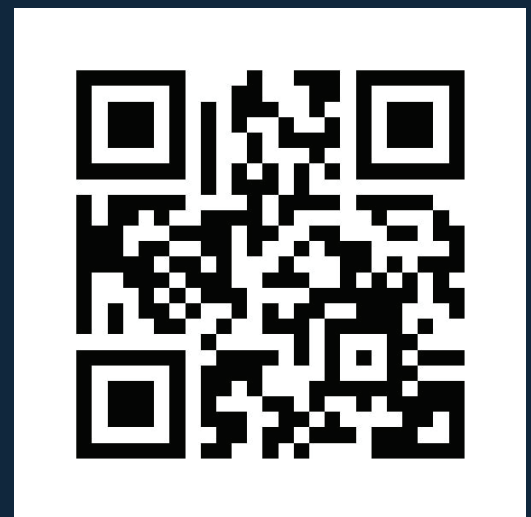
- fine reduction

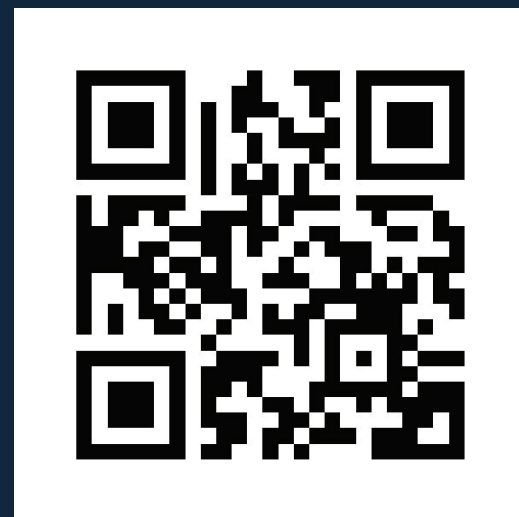
