## 1. CALL TO ORDER:

The Law Library Trustee met in regular session on Wednesday, January 10, 2024. The meeting was called to order at 12:20 p.m. by Trustee Halstead with the following trustees present - Neil Bowman-Davis, Brian Dewitt, Jim Jones, and the Honorable Victoria Wood. The Honorable Mark Boessenecker is excused.

## 2. ADOPTION OF THE AGENDA ORDER:

Motion moved by Trustee, the Honorable Victoria Wood and second by Trustee Anthony Halstead to accept the agenda order.

Motion passed 4-0.

- d. Anticipated decline in funds of Trust (based on new partnership with Sonoma Law Library), with increase in revenue based on increase in help from County. Projected fund balance in future will not be necessary. Goal is to have something in place for the Law Library that meets the needs of the community. Expertise of Law Librarian.
